1. The late Senator Joe Seng, a sponsor of the bill that became the Ag-Fraud statute, told ABC News about the intent of the law, "[h]ere's a commercial enterprise intent on biosecurity and here comes someone (who gets in) under false pretenses and screws up your whole system. 2. Senator Seng also told a reporter for Iowa Public Television that he supported the Ag-Fraud law because of a concern about potential health risks, stating "[m]aybe corporations or small farmers, they have their life savings invested in facilities, of utmost importance to these people are the fact they have invested money in keeping birds out of there poultry house vermin such as mice or rats, even cockroaches that type of thing from tracking in diseases from the outside." 3. Senator Seng also told a reporter that he supported the Ag-Fraud law because "The U.S. constitution says that you cannot enter a person's private property without formal knowledge. Even a policeman has to obtain a search warrant to get on a piece of property. These are private properties owned by either farmers or corporations that have strict bio-security facilities that do not want either birds, mice, vermin, anything like that, even cockroaches entering into these facilities -- people included." 4. Then-Representative Annette Sweeney, who authored an earlier version of the bill that became the Ag-Fraud statute, stated that she supported the bill because "[o]ur agriculture community needs some safe havens. We want to make sure we have as safe of a food source. With this bill we want to make sure everybody involved in our livestock facilities and working within in those facilities is forthright, and want to make sure our livestock is being kept safe."

5. Then-State Senate President Jack Kibbie told a reporter for the New York Times that he supported an earlier version of the Ag-Fraud statute because of a concern for bio-security, stating "[t]here's viruses that can put these producers out of business, whether it's cattle, hogs or poultry." 6. Then-Governor Terry Branstad, who signed the Ag-Fraud bill into law, stated, "If somebody comes on somebody else's property through fraud or deception or lying, that is a serious violation of people's rights—and people should be held accountable for that...That's very different from a whistleblower that sees something that's wrong, that is there in an appropriate and legal manner." 7. Then-Governor Branstad further stated that he supported the bill because "Agriculture is an important part of our economy and farmers should not be subjected to people doing illegal, inappropriate things and being involved in fraud and deception in order to try to disrupt agricultural operations."
