MOTION TO COMPEL OUTSTANDING DISCOVERY

Come now Plaintiffs, by counsel, and pursuant to Federal Rule of Civil Procedure 37(a) and Local Rule 37.1, hereby move the Court for an order compelling Defendants to respond to outstanding discovery by a date certain. Plaintiffs have unsuccessfully attempted to meet and confer on multiple occasions with Defendants in an effort to obtain this discovery in a reasonable timeframe.
